G. The chairperson extended a warm welcome to all the committee members. The following agendas were discussed in meeting.

Agenda No. 01: To review the minutes of previous IQAC Meeting

Discussion: The minutes of the previous meeting held on Saturday 31st of December 2022 were read by the IQAC coordinator and were accepted by all members.
