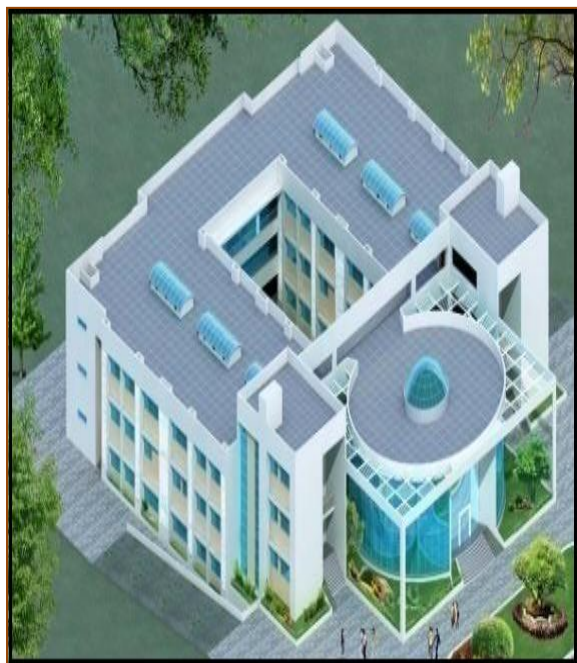

NCC MERP Index for Categorizing Medication Errors

Based on severity of the outcome

Definitions

Harm
Impairment of the physical, emotional, or psychological function or structure of the body and/or pain resulting from an error.

Monitoring
To observe or record relevant physiological or psychological signs.

Interventions
May include changes in therapy or active medical/surgical treatment.

Interventions Necessary to Sustain Life
Include cardiovascular and respiratory support (e.g., CPR, defibrillation, intubation, etc.).

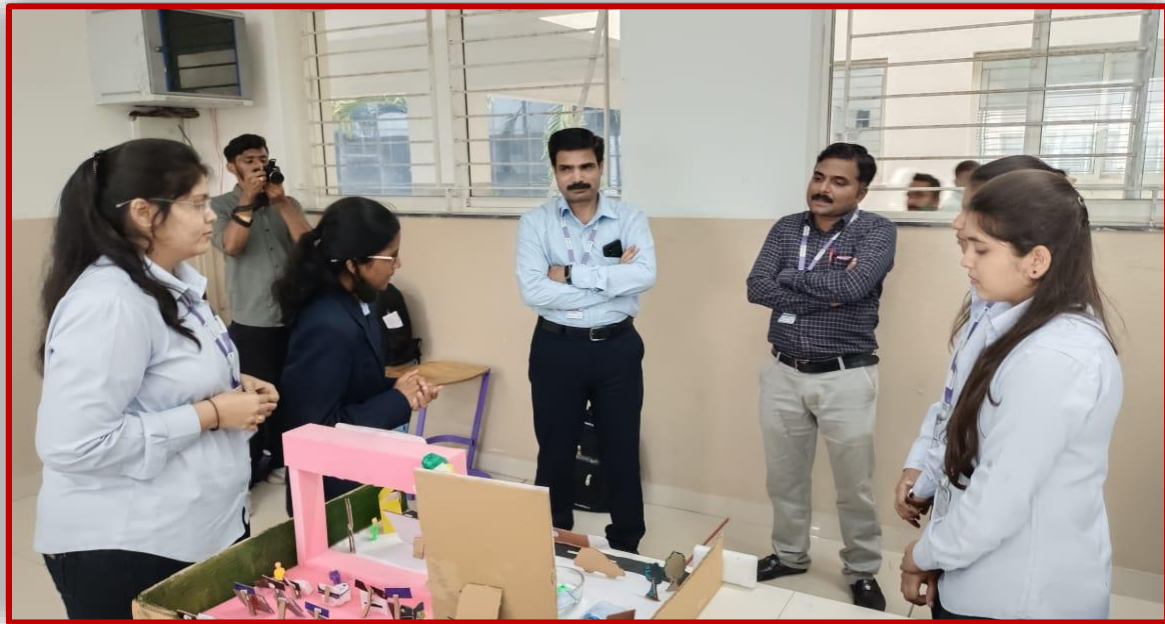
