



- **Obligations of faculty and researchers:**

- Research output will be considered one of the criteria for faculty recruitment and promotion along with other academic responsibilities.

- **Recruitment and Promotion:**

- Annasaheb Dange College of B Pharmacy, Ashta shall recruit such faculty members and researchers who have demonstrable/demonstrated capability in research. Faculty promotion may significantly depend on research undertaken. The quality of research output, especially research publications, may be assessed on the established yardsticks such as Impact Factor (IF) and which will be revised from time-to-time as appropriate.

- **Research Management:**

- Overall management of research activities may be coordinated by Research Head, Annasaheb Dange College of B Pharmacy, Ashta under direct supervision of head of the institute.
  - Each department research activities will be coordinated by HOD or the nominations from each department.

## 6. Research Initiation and Research Strengthening:

- The institute offers support to young faculty of institute to undertake research projects under 'Research Initiation Scheme'. This scheme is available from Institute funds. The research proposals from teachers and students are invited. The selected project is given with seed money to carry out the research activities.
- Institute promotes publication / presentation of research project /paper by student and staff in the State level, national, international conferences, seminar etc. Institute offers support of maximum 50% of total cost including registration fee, travelling charges etc.
- Research grants or funds fetched from the government and non government funding agencies will be utilized to serve the purpose of research project.

## 7. Rights and Responsibilities in the Conduct of Research

- **Responsibilities of Research Guide and Teachers:**

- The institute is committed to demonstrate support and appreciation for its students, teachers and staff members for achieving research goals through mutual cooperation. Teachers and research guides must facilitate compliance of this policy in all academic and research activities. The Head/Coordinator of the Department, Research Guide and senior teachers shall ensure that a research climate of mutual cooperation is created so that members of a research team are encouraged to develop their skills and exchange of ideas. Teachers and research guides also need to ensure that approved research protocols are

followed. Faculty members must be aware of their duties and responsibilities towards students and staff working as a part of the research team. It is particularly important that at least annually, each research guide shall review intellectual and tangible property rights and responsibilities (for management of data in all media, for proper authorship attribution, etc.) with all members of the research group under his or her direction.

**\* Responsibilities of Research Students:**

- All students engaged in research and those engaged in research within and/or for the institute, must familiarize themselves with the research policy and ensure that its provisions are observed. Researchers are expected to understand and apply the following principles:
- Researchers shall be honest in respect of their own actions in research. This applies to the whole range of research work including designing of experiments, generating and analyzing data, applying for funding, publishing results, and peer reviewing the work.
- Researchers are accountable to the society, their profession, the institute where the research is taking place including the stakeholders involved and in particular, the sponsoring /funding agencies. The institute expects all researchers including research students, project fellows, etc. to observe the standards of research practice set out in guidelines published by scientific, learned societies, and other relevant professional bodies.
- Plagiarism, deception, fabrication of results and misrepresentation will be considered as serious offence, which can lead to disciplinary action as laid down by the University authority. Researchers are to report such cases of misconduct in an appropriate manner.
- Researchers should sensibly consider the potential negative consequences on their ongoing research activities, outcomes or outputs which impacts human and surrounding environment. Such research projects should be avoided to reduce the risk.


**\* Researchers aspire to the highest degree of integrity in their research through:**

- Committing no form of plagiarism or unauthorized publication.



- 1.811 TA / DA / Registration charges for travel within India for attending conference, workshops, seminars, and faculty development program**
  - 1.812 50 % of TA / DA / Registration charges will be paid to staff members for attending conference, workshops, seminars and faculty development program within India as per the rules given below:**

We have conducted our audit in accordance with the auditing standards generally accepted in India. Those standards required that we plan & perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement. An audit includes examining on a test check basis, evidence supporting the amount and disclosures in the financial statements. **2. Reporting of Segment Accounting -****a) About Geographical Segmentation -**

The area of operation of the educational institute is restricted to only one place situated at "Ashta", Taluka Walwa, District Sangli, Maharashtra State and hence there is no requirement of geographical segmentation for the courses conducted by the institute.

**b) About Business Segmentation -**

The educational institute runs two course of B. Pharmacy as well as D. Pharmacy wing at Same premises. The business segmentation require to show its two separate courses i.e. 1) B. Pharmacy & 2) D. Pharmacy wing and accordingly the two set of books of accounts have been maintained separately for each course. For the purpose of determination of students fees of both courses the financial statements of each course are prepared separately.

Accordingly only for the purpose of determination of fee i.e. B Pharmacy course the Receipt and Payment Account, Income and Expenditure Account and Balance Sheet as on 31-03-2020 of B. Pharmacy Course (excluding its D Pharmacy wing) are prepared & reported upon along with the necessary schedules.

3. The educational institute has kept proper books of accounts required for the purpose of conducting audit for the relevant course i.e. B. Pharmacy (excluding its D Pharmacy wing).
4. While conducting the audit, we have observed that the internal control system is deficient in respect of expenses incurred and considering the size & volume of the transactions of the institute it is necessary to improve it adequately to safeguard the interest of the educational institute.




