Admissions in vacant seats after CAP Round

The Principal of the institution shall carry out the admissions for these seats in the following manner-

- (a) Admissions will be made in a transparent manner and strictly as per the Inter-Se- Merit of the Candidates who have applied to Competent Authority and then to the institution.
- (b) All the information in the brochures has been displayed on the Institution's website.
- (c) Institution invites applications by notifying schedule of admission and the number of seats in each course to be filled by the institution, by advertisement on the website of the institution.
- (d) Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall apply to the Principal the institution for admission at the Institution level as provided in rule 3(4)(b) and shall be filled in on the basis of Inter-Se-Merit prepared by following the procedure specified in rule 8 (3) of these Rules.
- (e) The institution, after verification of all required documents, will display the inter-se-merit lists of the candidate to be filled in at the institution level, in institutional quota along with vacant seats after CAP, on the notice board and will publish the same on the website of the institution.
- (f) All the admissions and cancellations shall be updated immediately through online system.
- (g) If any CAP seat remains or becomes vacant after the CAP Rounds then the same will be filled in by the Candidate from the same Category for which it was earmarked during the CAP. Further if the seats remain vacant then the seats will be filled on the basis of Inter- Se-Merit of the applicants.
- (h) While filling these seats the preference will be given to Maharashtra State Candidature Candidate over All India Candidature Candidate on the basis of Inter-Se-Merit.
